**Public Access** means that the public has access to publications and digital data sets arising from federally funded scientific research programs. everyone is able to **freely search**, **download**, **and analyze** unclassified publications and digital data sets unless specifically precluded by privacy, confidentiality or other security concerns.

#### US DOT's Public Access Plan applies to the following individuals:

- All DOT employees, including full- and part-time employees; as well as support service contract employees, consultants and temporary and special government employees.
- Awardees from non-DOT organizations that publish Scientific Research material or compile Digital Data Sets resulting from research and development programs conducted under a DOT grant, contract, or other agreement.
- USDOT's Public Access Plan designates ROSA P as the repository for deliverables of sponsored research.



- NTKN Cooperative Digitization Community of Practice bi-monthly informal meeting to discuss collection development, cataloging, digital rights, promotion, contracting and best practices for digitizing transportation collections. Participants also focus on eliminating duplication of effort.
- NTKN 508 Accessibility Community of Practice bi-monthly informal meeting to review best practices and tips for complying with Section 508 of the Rehabilitation Act of 1973 (29 USC § 794d).



#### **GPO (Government Publishing Office)**

- Recently proposed agreement of partnership focusing on sharing metadata, coordination and support for digital preservation efforts.
- In September, GPO delivered a report containing information on the 25,696 bibliographic records for the TD SuDoc classification stem (Dept. of Transportation). The report will be used to verify titles and other bibliographic data needed for identifying and cataloging USDOT publications.
- Currently working on authority files for agencies or sub-agencies that become Department of Transportation through mergers. We will use the information to create new authorities for retrospective work, both for ROSA P and to submit to GPO if warranted.
- Opportunity: GPO is setting up a Retro Media Team to establish guidelines for archiving government information published on CD-ROM. NTL is invited to submit content to the team.


#### **Civil Aeronautics Manuals**

- Civil Aeronautics Manuals published by the Civil Aeronautics Board from 1938 through 1962.
- 485 manuals and supplements containing guidance on specific civil air regulations.

### **Advisory Circulars**

 FAA documents concerning how to comply with airworthiness regulations published 1957 to 2000. The FAA Advisory Circular System was established for the publication of nonregulatory guidance and informational material to the public. 2092 circulars in the collection.

#### DOT Newsletters in process for digitization



#### **Department of Transportation News**

- U.S. DOT news releases, includes coverage of transportation planning, energy, environment, highway transportation, and research management.
- 3646 issues published from January 1969 to May 1997.

#### Department of Transportation Climatic Impact Assessment Program Newsletters

- News releases covering the assessment and study of the atmosphere including complex interactions among pollutants and emissions.
- 60 issues published from July 1972 to April 1975.

#### **Consumer Transportation Topics Newsletters**

- Published by US DOT Office of Consumer and Public Affairs to inform the consumer about the DOT's activities. Topics include transportation planning, energy, environment, and highway transportation.
- 32 issues published from July 1974 to July 1978.

#### **FHWA Federal Lands Highway Planning Reports**

- Published by FHWA Federal Lands Planning Program, these are multi-part studies and management plans for transportation applications relative to activities to and within Federal Lands
- 32 documents delivered, more expected.

#### **FHWA Digitized State Maps Collection**

• 1800 state maps digitized by FHWA Research Library. 37 Texas maps OCR'd and delivered to NTL on hard drive.

- Revised NTL work processes for copyrighted and open access journal articles, created documentation, communicated changes to DOT partner librarians
- Working with CENDI Copyright Working Group to develop Federal guidelines and statements for reuse
- SOS Publications Working Group currently defining grey literature types and how they relate to rights
- Implement NTL digital submissions form in 2023
- Update NTL Collection Development policy
- Enhance Science.gov to connect users with agency scientific integrity policies
